(THOSE WHO APPLIED AFTER GOT HKSAR – HK SPECIAL ADMINISTRATIVE REGION PASSPOST WHICH MEANS THEY ARE CHINESE AND ARE NOT ELIGIBLE TO REGISTER).

(Limited Electoral Rights – they can vote in local elections & European Parliamentary Elections if they apply. They are not entitled to vote in UK Parliamentary Elections).
