## Fee Exemptions

No fees are payable for the provision of regulated entertainment ONLY in respect of applications for Premises Licences, Club Premises Certificates and variations to Premises Licences and Club Premises Certificates in relation to:

- (a) Schools and colleges where the regulated entertainment is carried on by the educational institution for and on behalf of the purposes of the educational institution, or
- (b) Premises that are, or form part of, a church hall, chapel hall or other similar building or a village hall or community hall or other similar building

The same exemptions apply to an annual fee charge for Premises Licences and Club Premises Certificates.

Colleges are defined as a college or similar institution principally concerned with the provision of full-time education suitable to the requirements of persons over the compulsory school age who have not attained the age of 19.

## Refunds

There are no refunds for Premises Licences, Club Premises Certificates, Personal Licences or Temporary Event Notices and all associated application processes under the Licensing Act 2003.
